

he Foundation Report



The year 2014 was the 100th year celebration of community foundations. The first community foundation was set up in Cleveland in 1914 by Frederick Goff and operates now as the Cleveland Foundation. Others soon followed and since the 1980's a number of private foundations in the United States have created initiatives to develop

community foundations in various states. One of the earliest such initiatives was right here in Indiana with the Lilly Endowment funding a program that has spurred development of community foundations in each of the state's 92 counties. The Scott County Community Foundation was organized in 1997. Growing from ground zero that year to where we are today, the SCCF has awarded scholarships and grants of more than \$3 million, which is a phenomenal average of \$170,500 per year. We awarded \$250,540 in grants and scholarships this past year. At year end, 2014, SCCF had total assets of \$7.7 million under management.

Many people ask, "Who are you and what do you do?" My answer is that community foundations are independent registered philanthropic institutions serving geographically defined territory, ours is Scott County, Indiana. The main characteristic of a community foundation is that it is supported by a broad range of private as well as public donors and seeks philanthropic contributions primarily from inside the community. It is governed by multi-sectoral local boards reflecting the community in which it serves. Community foundations build capital endowment, which is an important element of sustainability and our mission, broadly defined, is to improve quality of life in a community by awarding grants to support projects.

Families, individuals, businesses, and nonprofit groups can establish funds within the SCCF into which they can contribute a variety of assets to be used for charitable purposes. The people or organizations that establish the funds can then recommend that grants be distributed, in the name of the fund or anonymously, to qualified nonprofit groups and schools. The donor receives a charitable deduction in the year in which gifts are made into their funds. The assets of the community foundation are pooled and invested. The established funds can be non-endowed or expendable funds, or they can be endowed, which limit distributions to the interest earned on the assets and/or the amount granted by the foundation as long as the principal is not spent. Endowments last in perpetuity due to the principal never being able to be spent.

A strong and popular addition to the SCCF is the Youth Grantmaking Council (YGC). This group was organized in 2001 and includes youth in 5th - 12th grade. At the end of our fiscal year their membership totaled 36 youth. The youth raise funds throughout the year and follow the policies of SCCF to grant out the earnings from their endowment funds for youth-related projects.

The stability of the future of the SCCF is strong. In Scott County the estimated current net worth is around \$910 million. During the next 10 years, it is expected that \$282 million will transfer from one generation to the next. It is the goal of the SCCF that we can attract a small percent of those beneficiaries who care about the community and the people within, to know and understand what could be done with a community-minded philanthropic decision. If just 5% of this transfer could be directed to a long-range community support endowment fund, and figuring just a 5% payout grant, this would generate about \$710,000 a year to help secure the future of Scott County and go a long way for improving the quality of life.

In conclusion, we would like to give thanks to our supporters and donors and embrace them as partners in bringing about all of our accomplishments - the stories of gratitude, which are many, are listed on our website. Also, we would like to offer a call to action to those who would like to join our quest as we fulfill our dream by accepting gifts of stock, property, memorial gifts, workplace giving opportunities and many other non-monetary ways people can help such as volunteering of your time.

Nathan and Alice Bridge Memorial Fund

Matt LaMaster, Scottsburg High School graduate, chose to honor his grandparents' legacy through the establishment of the donor-advised Nathan and Alice Bridge Memorial Fund.

Nathan was a farmer, Mason, and Scott County councilman who was "always willing to lend a helping hand (along with an earful of politics) to his fellow neighbors," said LaMaster. Alice was involved in everything including church events, correspondent for the local paper, Sunday school teacher, and lay minister at Wesley Chapel. She also served on the Scott County Library board of directors, was a Farm Bureau Women's Leader, and a member of the old Harmony Chapel Extension Club. She was one of the first members of the Scott County Hospital's Guild when it began in the 1950s.

"Beyond their causes, they were the root and trunk of a mighty tree that has reached far into the world," said LaMaster. "Each one of us is an acorn from that tree, which carries along, and keeps alive the brilliant memories of Nathan and Alice."

By establishing an endowment fund at the Community Foundation, LaMaster hopes that donations will serve as the root and trunk of the endowment "tree."



"In this way, the fund will live indefinitely providing charitable grants or "acorns" to those in Scott County," said LaMaster. "I invite you to join in contributing to the memory of an unforgettable couple to honor their enduring legacy."

Robin Eve Memorial Fund

Robin Eve was known throughout the community by many who would see her walking with her mother, Mary, always with a smile on her face and a compliment to accompany her greeting. Robin had worked for Blue River Services and Futures Unlimited, and she took her work seriously, always doing her job to the best of her ability and enjoying it at the same time. When she saw others who had disabilities more severe than hers, she would take them under her wing and make sure they were taken care of. She had also competed in Special Olympics. More than anything, Robin and Mary cherished the simple things in life. Mary had an electric organ and enjoyed playing music.

"They loved going to the parks to sit and people-watch, feed the ducks, watch kids play," said Mayor Bill Graham, a close family friend.

Mary passed away in 2012, and Robin died at the age of 57 on June 21, 2013. Mayor Graham and Robin's cousin, John Kurtz Sr., coordinated with numerous family members who were entitled to portions of the estate, to give up their share to provide a benefit to something that Robin loved so much. The Robin Eve Memorial Fund will support Scottsburg parks.



"Robin was one of the most loving, compassionate people that I have ever known," shared Mayor Graham. "Robin and Mary would be tickled to death and very pleased to know their money is going to benefit children, disabled and elderly people who enjoy the parks."

Educational Initiatives

Dolly Parton Imagination Library

The Dolly Parton Imagination Library initiative in Scott County continues to grow! Established in January 2013 in partnership with United Way of Scott County to address early childhood literacy, the program provides free age-appropriate books mailed directly to a child's home each month from birth through age five. Parents and guardians have shared what a blessing this program has been to their entire family.

We continue to surpass the projections for registered children provided by the Dollywood Foundation. By the end of 2014, there were 528 children registered for the program, plus 138 children who "graduated" from the program when they turned five!

While it takes only \$25 to sponsor a child each year, it takes the support of our entire community to sustain the program. Many local individuals, businesses and civic organizations are sponsoring these children, for which we are very thankful. In addition, the Community Foundation's Board of Directors voted to establish an endowment fund this past year, showing our commitment to this initiative and our children.

We have also established an early childhood committee in collaboration with United Way. Comprised of local educators, parents and experts in early childhood, we will continue to monitor the progress of the program and seek new ways to ensure its success.

Education Matters Southern Indiana

The numbers show that educational attainment in our region is well below national averages and is having an impact on our community, people, and businesses. In Southeast Indiana, only 25% of our workforce has an associate's, bachelor's or professional degree, compared to 38% nationally.

To address this regional issue, the community foundations that serve Clark, Floyd, Harrison, Scott and Washington counties have partnered on an initiative called Education Matters Southern Indiana. The goal of Education Matters Southern Indiana is to help adult workers who started, but never completed, some form of post-secondary education.

This represents roughly 40,000 people in Southern Indiana. Our goal is to increase attainment numbers by 25% in the next five years (10,000 people).

Four solutions to the educational attainment issue have emerged from this collaboration: the need for a public awareness campaign, a peer mentor program, a financial aid database, and convenient programs to assist the adult learner with their goals.

We are pleased to announce a new program this year, the Hand Up Scholarship, which is a grant to WorkOne for clients in Scott County to achieve their educational goals. The funds can be used for tuition, fees, books, special clothing or equipment required for training or employment, travel expenses, GED testing or child

care. We are collaborating with the Scott County Partnership to establish a peer mentoring program for adults returning to college. We have also featured several stories this past year of adults who have returned to college, in the hopes of inspiring others to do the same.

Lilly Scholars receive 4-year scholarships for tuition expenses plus \$900 for books and required expenses. Hyeree Ellis, a graduate of Scottsburg High School, is attending DePauw University. The value of her scholarship is worth \$197,554. Lilly Endowment has awarded 33 scholarships through the Scott County Community Foundation since 1998.

"My first semester at DePauw is officially over. Among papers, tests, and continual laughter of living with 40+ other students, this semester was everything I hoped for and more. Being accepted into the DePauw Servicio en las Americas Program, I moved onto campus the last week of June. blessing I was given from the Lilly Endowment. Without this huge blessing, I would not be at DePauw pursuing my passions."
