\$122K in Grants Awarded during Community Grants Program

We are pleased to announce the awarding of \$122,000 in grants to several local agencies, which were honored at a recent grants breakfast.

The organizations, the purpose of the request and amount awarded are:

- CASA of Scott County, volunteer coordinator for children who are abused and neglected, \$15,000;
- Child and Family Advocates, offer therapeutic support groups for children in separated and divorced families, \$5,000;
- Community Action of Southern Indiana (CASI), Life Literacy Academy, \$7,000;
- Gleaners Food Bank, mobile food pantry for senior citizens, \$5,000;
- Lexington Good Faith Preschool, provide free preschool for children in Lexington Township, \$6,000;
- New Creation Addiction Ministries, provide mileage to treatment centers to transport those with substance addictions, \$5,150;
- Scott County Family YMCA, afterschool program at Vienna-Finley Elementary School, \$5,000;
- Scott County Historical Society, purchase materials to preserve exhibits, \$2,500;
- Scott County Partnership, Conquer the Chaos (formerly Circles) poverty program, \$5,000;
- Scott County Partnership, Clearinghouse/AmeriCorps match, \$4,000;
- Scott County Partnership, CAPE educational initiatives, \$45,265;

- Scottsburg Band Parent Association, purchase new and updated instruments for SHS and SMS band programs, \$9,000;
- Scottsburg Football Program, purchase box trailer for football program, \$3,000;
- United Way of Scott County, \$5,000 to provide free books for children from birth until age five through the Dolly Parton Imagination Library program.

The Donald R. Collins Sr. Family Fund provided funding for the grant to the Scott County Historical Society. The L.L. and Juanita Lowry Unrestricted Fund assisted with funding for the grant to New Creation Addiction Ministries. Through the Collins and Lowry families' memberships in the Forever Tree Society, earnings from their family funds are able to support specific charitable projects in the community.

The Board of Directors also awarded \$45,265 from the Scott County CAPE Educational Endowment Fund to the Scott County Partnership to continue educational initiatives. These include LifeSkills and guidance activities at Austin and Scottsburg middle schools, coordinate youth summer feeding program in Austin, coordinate other educational programs including Reality Stores, Scott County Attendance Review Board, Youth/education Committee, Career Clusters, and more.

The grants were also made possible from the Laurence and Myrtle Bridge Memorial Fund, Terry Fewell Memorial Unrestricted Fund, Addie Mae Graham Memorial Fund, Lauren Graham Memorial Fund, Hazel and Lowell Lowry Sr. Memorial Fund, John and Janice Martin Unrestricted Fund, Dr. William and Diann Scott Unrestricted Fund, Dan and Mary Lou Slattery Fund, Scott County Immediate Response Fund, Scott County Memorial Fund and the Community Enrichment Fund.

Retired Educator Lois Nolan Passes

A kind person who encouraged hundreds of children during her teaching career, Lois Nolan, 72, Scottsburg, died on Monday, June 12, at a hospital in Louisville, Ky.

Lois was one of those people who never knew a stranger.

If she could help a child or adult struggling to comprehend, she'd go that extra mile with a willing student and do it in a way that made the individual happy to be involved and learning.

Lois taught for both local school systems, but she may be best known for her work with GED students, those trying to earn their high school equivalency degrees. She was also an instructor at Ivy Tech Community College, Strayer College and the former Henryville Correctional Facility. She was patient and dedicated, a true teacher in every sense of

the word.

With her husband Charles, Lois owned and operated the old Loaves and Fishes Christian Bookstore in Scottsburg as well as Nolans' Educational Consulting Services. They became more active in those businesses when they retired from their education-based jobs.

Believing that education is one of the best tools people can obtain to become successful, the couple established a scholarship fund with the Scott County Community Foundation in 2008 to help students. The fund has since awarded six scholarships to deserving students.

Her survivors include son Joel and daughter Bethany, her husband Brandon and three grandchildren.
