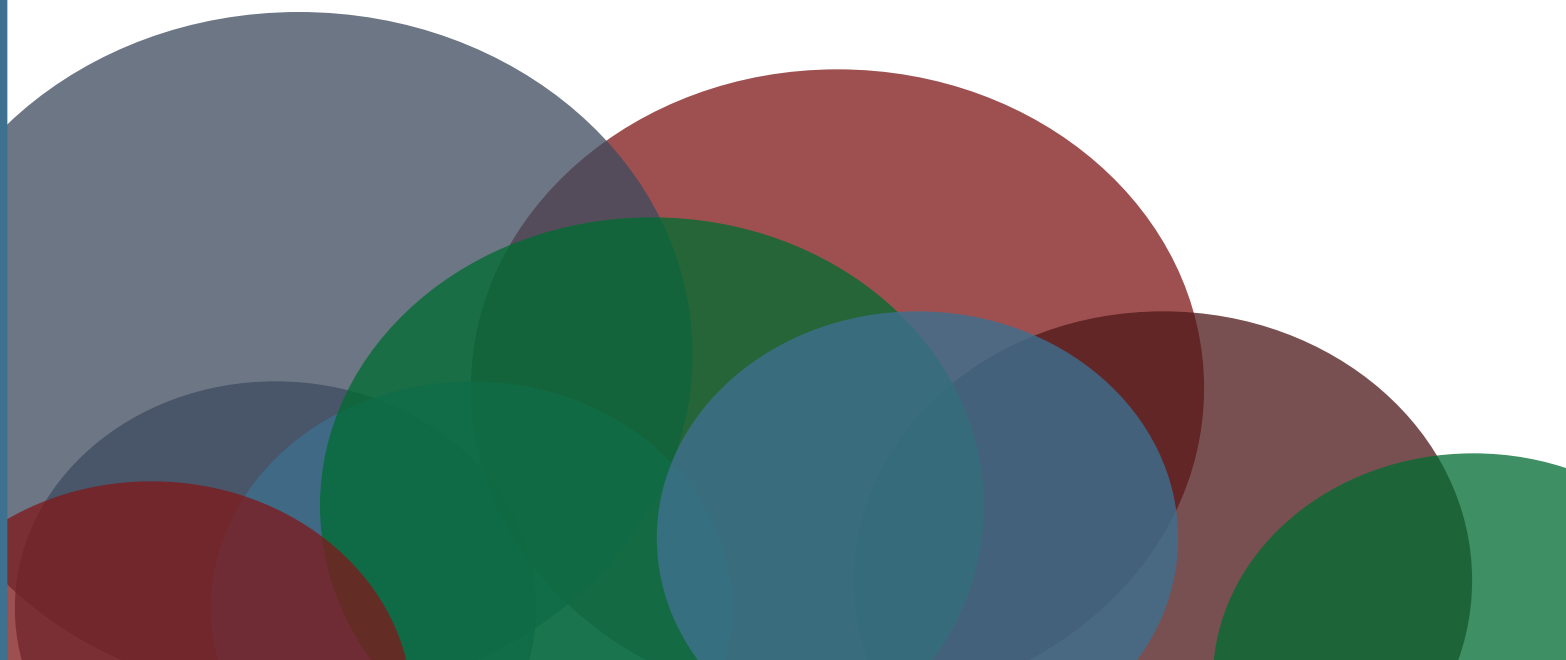

Our Mission: Growing and preserving charitable gifts to strengthen Scott County by looking forward and giving back

Dear Friends of the Foundation,

I hope you had a wonderful holiday season and are looking forward to a great year ahead.

I write to you today filled with gratitude and excitement. The Scott County Community Foundation continues to grow and plant seeds for future generations in our community. We received news in late 2018 that we would be receiving a grant of \$216,161 as a part of Lilly Endowment Inc.'s seventh phase of its Giving Indiana Funds for Tomorrow (GIFT) initiative. Lilly Endowment will provide \$2 for every \$1 contributed to the Community Foundation's unrestricted endowments during the matching period of October 1, 2018, through December 31, 2020. This is an amazing opportunity and we cannot wait to spread the benefits of this grant and of all the great things it will make possible for Scott County!



Looking back at this past year, we have been astounded and humbled by the deep unselfishness of so many in our community as we continue to see your generosity in contributing to the Community Foundation. These resources will impact many individuals and nonprofits in the Scott County, and we are honored that many of you chose to partner with us to help you best achieve your charitable goals. Types of Funds

Designated	Donor Advised	Scholarship	Pass Through	Unrestricted	Field of interest
These funds are for a school, government agency, or specific 501(c)(3) charity selected by the donor, such as a museum or church.	These funds provide support to qualified charitable organizations or purposes with input from the donor and/or family/representatives.	These funds are for students to receive assistance for educational expenses. You may place restrictions on the scholarship, and the Foundation's scholarship committee selects the best candidate, with your advice if you so choose.	A "charitable checking" account. A donor may recommend several organizations in which to receive funding. Funds are not invested in the market.	You place no restriction on how the fund is to be used, entrusting those decisions to the Board of Directors, now and generations to come.	These funds are for a general field selected by the donor, such as arts, education, healthcare, etc.

All contributions to the Community Foundation between October 1, 2017 through September 30, 2018, are acknowledged on our website.

Kelley Robbins Endowment Fund for Public Health



Kelley had a passion for public health. His father advocated for public health as a County Councilman; his mother worked for the health and welfare department, his sister served as a school nurse, and his wife has served as the long-time WIC Director. Kelley himself served as a Councilman and Commissioner, and he was committed to ensuring the future of Scott County's health remained a priority. "I think (improving local health services) is one of the best things we've done in a while for our residents. We need to concentrate more on living better lives, healthier lives," said Kelley. When Kelley passed away in February 2018 after battling cancer and heart problems, his family established this donor-advised fund. Through this endowment fund, they can recommend grants that they feel would support Kelley's vision for a healthier community.

Nina Keown Memorial Fund



Nina loved her family and her little town of Lexington. She enjoyed spending time with friends and was very social. She was tragically killed in an act of domestic violence by her ex-husband in 2010. Her family established this fund, knowing that good work will be done in her memory. As a donor-advised fund, her family plans to support the Lexington community and victims of domestic violence.

Scott County Genealogical Society Fund



With many people curious about their ancestry, more and more are using research methods to discover their family history. The Scott County Genealogical Society was formed in 1992 by volunteers who were dedicated to saving family histories. Research rooms at the Scott County Heritage Center and Museum were opened in 2003 and have helped numerous people discover interesting facts about their family lineage. The SCGSI Board decided to establish an endowment fund to ensure their efforts are supported for many more generations.

Early Childhood Initiative

Our Board of Directors has placed a strategic focus on early childhood education. Our Early Childhood Committee hosted early childhood provider roundtables, family literacy events and a resource fair. We also partner with neighboring counties to address kindergarten readiness.



Dolly Parton Imagination Library program

Six years ago we partnered with United Way of Scott County to bring the Dolly Parton Imagination Library program to Scott County. Over 47,000 free age-appropriate books have been mailed directly to children's homes each month, helping to meet our goal of increasing early childhood literacy.

By the end of 2018, there were 933 children registered for the program, plus over 850 kids who "graduated" from the program when they turned five. Through donations from individuals, businesses and civic organizations, as well as grants, community support has helped to ensure this program can continue.

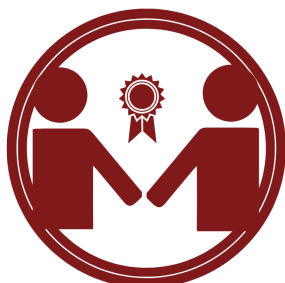


Shown is 3-year-old Natalie. "Natalie loves getting books in the mail," said her mom. "I read her the book and then she practices reading it on her own from memory."

Lilly Scholars receive 4-year scholarships for tuition plus \$900 for books and required expenses. Isaak Mount, a graduate of Scottsburg High School, is attending Indiana University. He is majoring in mathematics/economics. The value of his scholarship is \$48,837. Lilly Endowment has awarded 37 scholarships through the Scott County Community Foundation since 1998.

“Coming into college I was nervous, as everyone probably is but never wants to admit. I didn’t know if I would meet good friends, enjoy my classes, or run out of meal points in the first month. Thankfully, the friends part was taken care of once I auditioned for the IU Marching Hundred Drumline. 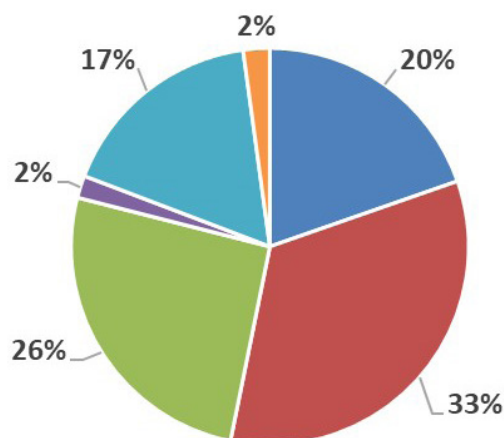

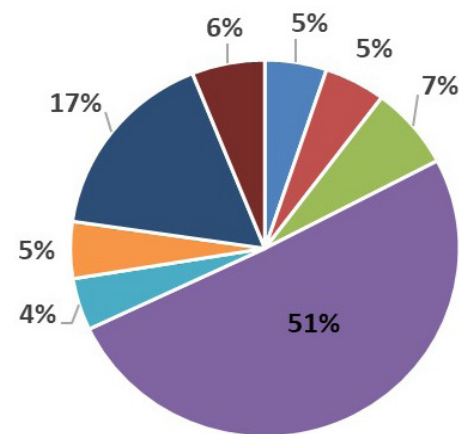
