2020 Community Grants Program Recipients Announced

We are excited to announce we have awarded over \$138,000 in grants to several local agencies during our 2020 Community Grants Program. The agencies will be formally honored at a grants breakfast in August.

The organizations, the purpose of the request and amount awarded are:

- Align Southern Indiana: operations for the 5-county initiative which works to align resources, address needs and produce sustainable solutions, \$5,000;
- CASA of Scott County: provide mileage reimbursement for staff to support abused and neglected children, purchase fundraising tracking software, \$19,000;
- Child and Family Advocates: provide support groups, classes and online parenting curriculum to children of divorced/separated parents, \$5,000;
- Englishton Park: summer camp remediation program, \$2,000;
- Gleaners Food Bank: provide BackSacks of food for children every weekend during the school year, \$5,000;
- LifeSmart Youth: provide human growth and development curriculum to Austin elementary and middle school students, \$5,000;
- New Creation Ministries: expand training material and equipment for individuals who are facing life-controlling situations, operational support, \$5,000;
- Preservation Alliance, Inc.: operational support for Scott County Heritage Center and Museum, \$1,500;
- Scott County Fair Association: complete remainder of pole installation around track at fairgrounds, \$10,000;
- Scott County Partnership: AmeriCorps match for Clearinghouse, and Conquer the CHAOS high school poverty initiative, \$7,830;
- Scott County Partnership: program match for Covering Kids and Families health insurance navigator,

\$7,000;

- Scott County Sheriff's Department: purchase in-car radios, \$5,930.10;
- The Refuge for Children, hire consultant to complete application for licensing for children's home, \$4,000;
- THRIVE Recovery Community Organization: purchase items for Recovery Engagement Center, \$4,421;
- United Way of Scott County: provide free books for children from birth through age five through the Dolly Parton Imagination Library, \$5,000.

The Donald R. Collins Sr. Family Fund provided funding for the grants to Preservation Alliance Inc. and CASA. The L.L. and Juanita Lowry Unrestricted Fund provided funding for the grant to New Creation Ministries. The Dale and Rosemarie Hobbs Fund provided funding for the grant to Englishton Park. The Laurence and Myrtle Bridge Memorial Fund provided funding for the grant to United Way for the Imagination Library. Through these families' memberships in the Forever Tree Society, earnings from their family funds are able to support specific charitable projects in the community.

The grants were also made possible from the Borden Family Community Granting Fund, Terry Fewell Memorial Unrestricted Fund, Addie Mae Graham Memorial Fund, Lauren Graham Memorial Fund, Hazel and Lowell Lowry Sr. Memorial Fund, John and Janice Martin Unrestricted Fund, Neighbors Helping Neighbors Fund, Dr. William and Diann Scott Unrestricted Fund, Dan and Mary Lou Slattery Fund, Wesbanco Fund, Scott County Immediate Response Fund, Scott County Memorial Fund and Community Enrichment Fund.

The Board of Directors also awarded \$46,515 from the Scott County CAPE Educational Endowment Fund to the Scott County Partnership to continue educational initiatives. These include LifeSkills and guidance activities at Austin and Scottsburg middle schools, coordinate youth summer feeding program in Austin, coordinate other educational programs including Reality Stores, Scott County Attendance Review Board, Youth/education Committee, Career Clusters, and more.

YGC Awards Funding for Youth Projects

YGC members awarded \$7,033 in grants to youth-related projects in the community. The YGC is hoping to formally honor recipients at an annual dinner later this summer.

Austin High School received \$800 for "Life Skills in the Community." Teacher Lee Anne Hahn will take her students on restaurant outings to help teach life and social skills.

EMPOWER of Scott County received \$300 for "Town Hall Meeting on Resilience." They will host a town hall meeting this fall for the release of resilience videos that will feature students in our community, along with a community discussion about trauma and the importance of building resilience.

Grace Christian Academy received \$320 for "Treekeepers Documenting Scott County." The Treekeepers environmental/history class has been learning about Scott County history and the Bicentennial, and would like to document programs and events for the Scott County Heritage Center and Museum.

Happy Humming Alpacas 4-H Club was awarded \$750 for "Alpaca Enclosures." This club has had a large increase in members and needs more housing for the fair.

Johnson Elementary School received \$500 for "Hero Program." This initiative focuses on positive student behavior and will provide field trips as incentives.

Scott County Robotics received \$516 for "Building the Future." The Scott County High School Robotics Club is a joint effort between Mid-America Science Park, Austin High School, Grace Christian Academy, and Scottsburg High School to promote robotics. They will buy supplies to prototype and test ideas, then assemble into a finished project.

Scott County Young Marines received \$600 for "Young Marines." They will host a two-night encampment at Hardy Lake. This organization teaches marching, physical training, drug demand reduction, history, patriotism, and community service to youth.

Scott County Youth Football League received \$500 for "Youth Sponsorship." There has been an increase in the number of families requesting financial assistance for children to play football.

Scottsburg High School received two grants. Jennifer Morris was awarded \$500 for "Fellowship of Christian Athletes." They will host meetings, Bible studies and outreach events. Shawna Slaton was awarded \$1,000 for "eSports Teams." They will purchase equipment for this newly-formed opportunity for gamers.

Scottsburg High School Theatre Boosters received \$447 for "Microphones for theatre program." The high school's drama club has had a huge increase in students with more elaborate productions and a need for additional microphones.

Scottsburg Middle School was awarded \$800 for "Community Based Instruction."

We also had a former YGC member come back as an applicant now that he's an adult volunteering in our community! Thank you to Knights of Columbus for hosting us.

The special education classes will learn skills such as traffic safety, reading a menu, ordering a meal, making correct change, and social skills through restaurant outings in the community.

"Given the circumstances this year the YGC is fortunate enough to still positively impact our community through the grants given out," said grants committee co-chairperson Hannah Brown. "We are thankful to have such a great community that has such amazing programs! We are looking forward to the future to see how the grants impact our community."

"As this year was different for all, the YGC is honored to still have the ability to continue to support local charitable organizations within our community. We hope that this money can have a positive impact on many lives in Scott County," said grants committee co-chairperson Elle Fleenor.
