Scott County's Transfer of Wealth Brings Opportunities

The Board of Directors has recently started a longterm visioning process with the help of Indiana Grantmakers Alliance (IGA). We have been honored to help our donors with your charitable giving over the last 16 years, which has been able to provide Scott County with almost \$3 million in grants to charitable organizations. As we head into the future and determine how we can best meet our donors' needs, we have found some interesting information to share.

Several years ago, IGA commissioned the Center for Rural Entrepreneurship to study the transfer of wealth in Indiana, which is when wealth passes from one generation to the next. This includes cash, land and other assets. You may be surprised to learn that Scott County's wealth was estimated at \$910 million in 2010, and it was projected that over the next 10 years, \$282 million would transfer between generations.

This transfer of wealth can bring a message of hope and opportunity to build our community. Our board was posed with the question, "What could we do if we captured just 5 percent of that wealth through endowment funds at the Community Foundation?" This would result in an additional \$705,000 available for grants each year!!

More important than the dollar amount is the impact that could be made with those funds. Ideas expressed in a video envisioned funding walking and biking trails, a downtown historic district, scholarships to send students to college, the ability to fully fund the Dolly Parton Imagination Library program to provide free books to children, and breaking the cycle of poverty.

The possibilities are endless, and while it is fun to dream, we want to make those dreams a reality for Scott County! And we can, if each person gives just 5 percent of their wealth.

Over \$103,000 Awarded in Grants to Community

We are pleased to announce the awarding of over \$103,000 in grants during our 2013 Community Grants Program.

The organizations, the amount awarded and the purpose of the request are:

- Big Brothers Big Sisters of Scott County received \$4,760 to purchase a webbased case management system and provide pre-match trainings.
- City on a Hill Church, \$2,523 to purchase medical equipment for free community medical screenings
- Englishton Park, \$7,000 to send seven Scott County children to a summer remediation camp
- Gleaners, \$10,000 for the BackSacks program, which provides food to Scott County children every weekend during the school year
- Lexington Good Faith Preschool, \$6,750 to provide free preschool to children in Lexington Township
- LifeSpan Resources, \$1,350 for a web-based prescription assistance program
- Preservation Alliance, Inc., \$2,222.77 for operating support for the Scott County Heritage Center and Museum
- Scott County 4-H, \$3,000 to implement Project LEAD at Scottsburg Elementary School, a program that will educate fifth grade students about law enforcement, the legal system and making good decisions; and to fund youth development/

education programs

- Scott County Economic Development Corporation, \$2,685 for a Veteran to Business program, which includes entrepreneurship training, mentoring and advisory services
- Scott County Genealogical Society, \$1,937 for books for the research room and archival materials
- Scott County Historical Society, \$1,120 to purchase a computer and printer to enable archiving and researching
- Scott County Partnership, \$2,500 for the Circles Campaign to end poverty
- Scott County Partnership,
 \$4,000 for the Clearinghouse to assist needy families
- Scott County Sheriff's Posse,
 \$6,350 to purchase radios so members can effectively communicate during search and rescue, emergency response and other activities

Funding for two projects was made possible from the Donald R. Collins Sr. Family Fund. The Scott County Family YMCA received \$375 to purchase new lane lines for the swimming pool. Part of the grant to Big Brothers Big Sisters was also made possible through the generosity of the family. Through the Collins family's membership in the Forever Tree Society, earnings from the family's fund are able to support specific charitable projects in the community.

In addition, part of the unrestricted funds included \$5,000 that the Board of Directors designated for the Imagination Library program, an initiative that provides free books to children from birth through age five. The Community Foundation has partnered with United Way of Scott County to bring this program to the community in an effort to increase early childhood literacy.

The Board of Directors also awarded \$41,678 from the Scott County CAPE Educational Endowment Fund to the Scott County Partnership to continue educational initiatives.

The grants were also made possible from the Addie Mae Graham Memorial Fund, Lauren Graham Memorial Fund, Hazel and Lowell Lowry Sr. Memorial Fund, L.L. and Juanita Lowry Unrestricted Fund, John and Janice Martin Unrestricted Fund, Dr. William and Diann Scott Unrestricted Fund, Scott County Immediate Response Fund, Scott County Memorial Fund and the Community Enrichment Fund.

"As in years past, the grants committee had a difficult time deciding which organizations to award grants," said Hank Jentzen, chair of the grants committee. "The Scott County Community Foundation would like to congratulate those who have received funding, and thank all the applicants for their desire to make Scott County a great community to live in."

"With over \$160,000 in requests, it was an extremely competitive process and there were so many deserving projects."

YGC Awards Grants For Youth

The Scott County Youth Grantmaking Council awarded over \$3,400 in grants to youth-related projects in the community at an annual dinner held June 4 at First Southern Baptist Church.

- Austin High School received \$275 to purchase stage curtains and backdrops for the Dimensions Show Choir.
- Austin Middle School received \$400 to provide restaurant outings for students with disabilities, in order to teach social skills.
- Lexington Good Faith Preschool received \$200 to assist with transportation costs for students at the free preschool in Lexington Township.
- Scott County 4-H received \$337 to purchase dog obedience equipment.
- Scottsburg High School received \$600 to purchase equipment for the archery club.
- Scottsburg Middle School received \$800 to purchase a scoring machine for the archery team.
