### **Thoughts From Our Chairman**

Dear Friends of the Foundation,

I currently have a small pile of scrap pine boards at home sitting atop the counter in my living room. Nearly twenty years ago, the individual planks were placed together with a specific purpose in mind, and represented something useful: a foot stool built during my 7th grade year in Mr. Busick's class at Scottsburg Middle School. While I followed Mr. Busick's instructions closely and carefully, some minor modifications might have extended the life of the stool had we anticipated the rigorous stress and multiple uses the stool would one day become subjected to, being pulled from room to room by my two young daughters.

A proper foreshadowing of the stool's fate exists in words penned by John C. Maxwell, who once wrote that "Every asset that you're entrusted with—whether it's money, procedures, materials, technology—all of it is depreciating. All of it is becoming obsolete." In the case of the stool, Mya, my youngest daughter, helped expedite the process of obsolescence, as an offcentered stance (while checking the growth of her flowers sitting on the windowsill) proved more than the stool could handle.

In their current state, sitting idly atop the counter, the pine boards hold relatively no great value other than serving as a tangible reminder of lessons learned, and of what used to be. The pine boards take up space and don't provide any type of decorative benefit to the room, yet I hesitate to dispose of the boards. The boards once had a purpose, and when I near the point of discarding the boards, I convince myself that if proper care is provided, those boards may once again have purposeful meaning for years to come.

### Family Establishes Nathan and Alice Bridge Memorial Fund


We would like to thank Matt LaMaster for sharing this story with us about his grandparents and why he decided to honor their legacy with an endowment fund. Not only will the impact of this fund be felt for generations to come, the entire family will become involved with the philanthropic process by helping make the decisions on where the grants should be awarded.

"As many of you know, I have been working with family members to establish an endowment fund in the memory of my grandparents, Nathan & Alice

Bridge. I am excited and proud to announce, that an acorn endowment fund has been established in their name, and will be managed through the Scott County Community Foundation.

My grandparents were lifelong residents of Scott County. They loved the land, and were committed to their faith, family, and community. Some of my fondest memories are of Sunday evening meals, where the extended family (including my uncle, four aunts, and an ever increasing amount of cousins) would discuss events support grants, significant donors will have the of the day. Often these conversations would end with Grandpa Bridge exclaiming, "I'm going to get a board 8 feet long, and 20 feet wide", or (much to my Grandma Bridge's disdain) "I'm going to Louisville and am going to find a ....... " the rest cannot be repeated here.

They both had an unending curiosity and devout commitment to multiple causes. Grandpa Bridge was a farmer, Mason, and Scott County councilman who was always willing to lend a helping hand (along with an earful of politics) to his fellow neighbors. Grandma Bridge was involved in everything including church events, correspondent for the local paper, Sunday school teacher, and lay minister at Wesley Chapel. She



also served on the Scott County Library board of directors, was a Farm Bureau Women's Leader. and a member of the old Harmony Chapel Extension Club. She was one of the first members of the Scott County Hospital's Guild when it began in the 1950s.

Beyond their causes, they were the root and trunk of a mighty tree that has reached far into the world. Each one of us is an acorn from that tree, which carries along, and keeps alive the brilliant memories of Nathan and Alice.

Like the mighty tree

that was built by my grandparents, your donation to this endowment fund will serve as the root and trunk of the endowment "tree." The donation will not be gifted, but will grow as contributions are made. As the fund grows and generates interest; grants will be provided to charitable organizations within Scott County supported by Nathan and Alice. ## **Hyeree Ellis Selected as 2014 Lilly Scholar**

One Scott County student has been named recipient of a full-tuition, fouryear scholarship as the Scott County Community Foundation 2014 Lilly Endowment Community Scholar.

Hyeree Ellis of Scottsburg High School will receive full tuition to the Indiana college of her choice and a \$900 yearly stipend for required books and equipment.

Hyeree is the daughter of Michael and Inok Ellis of Lexington. She is the Student Council President and Class Vice President. She is the editor-in-chief of the school newspaper, a member of the Sunshine Society, and volunteers at Lexington Church, among other activities.

Hyeree plans to attend DePauw Uni-

versity to major in biochemistry with a minor in communications. She hopes to eventually attend medical school to become an oncologist.

"I am so grateful to be selected as the county's Lilly scholar," said Ellis. "I really didn't anticipate on receiving it, so it's a bit of a shock. I'm so excited to start my journey with the help of this scholarship!

"I remember sitting in class my freshman year and hearing about it...I never thought it would happen to me. It's really a dream come true."

"Hyeree Ellis will represent Scott County as an excellent Lilly Scholarship recipient," said Scholarship Committee Chairperson Barbara Broady. "In her written application,



essays and interview, she continued to demonstrate her leadership skills both in school and in the community."

Students were judged based on financial consideration, community involvement, extra-curricular activities, work activities, academics and two essays. Five students advanced to the interview portion. After the scholarship committee narrowed the field to one nominee and two alternates, the finalists' names were submitted to Independent Colleges of Indiana Inc. (ICI) for the selection

of the recipients.

ICI is a nonprofit corporation that represents 31 regionally accredited degree granting, nonprofit, private colleges and universities in the state.

The scholarships are the result of a co statewide Lilly Endowment initiative to help Hoosier students reach higher levels of education. Indiana ranks among the lowest states in the percentage of residents over the age of 25 with a bachelor's degree. There were 143 scholarships awarded statewide.

### Focus on a Fund: Austin Beautification Endowment

The Austin Beautification Committee was started by a group of people in 1994, and received ideas and help from the Scottsburg Beautification Committee. Their mission has always been to make Austin a better place to live and work.

"Together we can make it happen!" said Janie Alexander.

Special projects that the committee supports include perimeter lighting on the

downtown buildings. This was one of the first major permanent projects the group tackled.

"By showing how attractive our small city can be if everyone works together makes it apparent the future can be brighter," said Janie. Each year, the seasons are marked throughout Austin with different displays and events. Summer is highlighted by colorful flower pots placed through the business district to brighten everyone's path. Autumn is welcomed by displays placed around the welcome signs, Main Street and U.S. 31 of straw, pumpkins, mums and whimsical signs. To usher in the holiday season, the Committee sponsors and hosts an Open House following the Christmas parade on the first Saturday in December. The event is held in the old gym at the Austin School with refreshments, entertainment and visits with Santa and his elves.

The Austin Beautification Endowment Fund was established in 1999 at the Scott County Community Foundation to support these projects. Members have a goal of growing the endowment fund to continue funding these projects, and are asking for the community's support.
