## Abby Tremain Hired as Career and College Counselor Intern



Just over five years ago, life turned upside down for the Akers and Comer families. Shelley Comer Akers, a young

wife to Kyle and mother of two daughters, tragically died in a tractor accident.

Shelley was the office manager at Purdue Extension and was very active in the 4-H program. Therefore, it made

perfect sense to Kyle to establish a scholarship fund in her memory to benefit students who had been involved in 4-H.

Since that time, scholarships have been awarded to five students: Katie Burch, Shelby Hale, Ethan McNeely, Anna Hall and Leighanna Miller. All applicants are asked to write an essay on how they put the 4 H's in 4-H to good use in their life.

### "Why Didn't I Know?" Chairman's Message

Dear Friends of the Foundation,

How many times have you heard some of your friends or family members say, "Well, why didn't I know about that?" Most people can't wait to announce their bargain purchases with their families and close friends—whether it be the last bargain gasoline purchase, a great deal on a new car, or even an item of clothing found on sale. Most people love bargains and certainly like to take advantage of them if they know they are Scott County Community Foundation in the offering.

At the Scott County Community Foundation, we have one of the most amazing bargains going on right now that you could ever imagine, until March 31, 2016. Any contribution received at the SCCF towards an unrestricted fund (i.e., the Community Enrichment Fund, or any other established unrestricted

funds, or an unrestricted fund of your own that you can establish) will be MATCHED - dollar for dollar. In plain English, a \$500 gift immediately becomes \$1,000; a \$2,000 gift has a \$4,000 impact or a \$5,000 gift becomes \$10,000, etc. All other funds (Scholarship; Designated; Donor Advised or Field of Interest funds) are being matched \$.50 for every \$1.00 contributed during this period.

Board members, fundholders, and many of your friends are getting the word out right now - but, we need your help also by sharing with the people you know and informing the civic organizations and churches you belong to about this amazing opportunity before the March 31, 2016 deadline.

I certainly hope I don't hear those
