Dear Friends of the Foundation,

2020 was a year that none of us will ever forget. The COVID-19 pandemic turned everything upside down for our world. But while we endured challenges and tragedies, we feel it is important to focus on our blessings and how resilient our community is!

Things looked much different last year for the Community Foundation and our constituents. High school scholarship ceremonies were canceled, so we brought yard signs to recipients to celebrate their achievements. Our annual fundraising event was postponed, and eventually canceled - so we moved to an online auction format that many others had to do as well. We were in the middle of our Community Needs Assessment when everything came to a halt. Zoom meetings became the norm for many of us, and when we did meet in person, we were masked up.

Even with a fear about the uncertainty of the future, donors stepped up and supported their favorite causes. We re-activated our Disaster Relief Fund, and donors from advised funds quickly responded to immediate needs in our community. Our Youth Grantmaking Council adjusted their usual group service projects to allow youth to continue serving the community in any way they could - from mowing elderly neighbors' yards, to writing encouraging chalk messages to healthcare workers, to helping distribute food to those in need and much,

much more!

It was very common to hear stories about people anonymously dropping off gifts and lunch to strangers and friends to brighten their days. While it was very difficult to not see loved ones in the hospital or at nursing homes, people found ways to connect through notes, window visits, video chats and more. Because of the social distancing required, many people rediscovered our great outdoors and the many health benefits it offers. Families enjoyed a slower pace of life as activities were canceled.

Throughout this report you'll see faces of resiliency and our community coming together to serve others. You will read how grants, scholarships, and other programs have enabled our community to adapt and thrive in these challenging times. Part of being resilient means to embrace change and be optimistic. Things don't look the same as they did just one short year ago, but we want to celebrate the good that is happening in our community. We are thankful to you for your generosity and support, and we look forward to a return to normalcy this year!

We can help you choose a fund that will achieve your charitable goals.

Agency/Designated

These funds are for a school, government agency, church, or nonprofit. This allows the organization to receive annual grants as a dependable source of funding.

Field of Interest

These funds allow you to support a certain field, such as the arts, education, health care, etc. Or, you can support a specific geographic area. The Foundation's grants committee will handle the grant process for the area you have identified.

Donor Advised

These funds allow a donor to be involved in the giving. Perhaps you want to get your family involved and continue a legacy of giving. Each year you can recommend which charitable organizations or purposes to support.

Unrestricted

If you wish to provide resources to the community to meet current and future needs, this is the fund for you. You place no restrictions on this type of fund, entrusting the Foundation's grants committee and Board of Directors to choose quality and meaningful grants.

Scholarship

These funds assist students with educational expenses. You may customize your preference for a certain field of study or other criteria, and you can choose to be involved in the selection committee.

Pass-Through

This fund type is like a charitable checking account. Funds are not invested in the market.

Lasting Legacy

We honor those who have made a lasting commitment to our community by contributing charitable gifts to the Foundation through their will, trust, or other planned gifts.

Yellow Rose of Nancy R. Laird Memorial Fund

The yellow rose stands for joy and happiness. It symbolizes sunshine and brightness in our lives. Yellow represents joy, peace, warmness, to cheer up someone, lifting spirits, friendship and caring. "The yellow rose is a perfect description of Mrs. Nancy Laird, who was a loving and caring person," shared Scottsburg resident Hank Jentzen.

Due to the close relationship Hank had with her and her family, he and her son Scott have established an unrestricted fund in her memory.

"Looking back to my younger days in New Jersey, Mr. and Mrs. Laird always welcomed me into their home," said Hank. "I felt the love and warmth of their kind spirit. They were wonderful people and Mrs. Laird created a caring home for many young adults who were friends of their children."

"This past December, Mrs. Laird called me and told me she always thought of me as one of her sons," shared Hank. "We reminisced about the old days and had a few laughs. That was the last time I talked to her. She passed away just before Christmas of 2019."

Having been a longtime grants committee and board member for the Community Foundation, Hank was familiar with the far-reaching impact made in the community through unrestricted funds.

"Over the years I have tried to give back to her for her kindness by hopefully making her final years a little more joyful. Now it only makes sense to create an unrestriced fund in her memory. The fund will ensure her kindness will live on forever, and help create a better community now and for generations to come," said Hank.

"My life has been made better for knowing Mr. and Mrs. Laird. Scott and I decided that an unrestricted fund was the best way to help others now and forever. This fund is our way to say thank you, and knowing her kindness and generosity will continue to help others in the community forever through the Scott County Community Foundation is a great feeling," said Hank.

Carter-Waldkoetter Nurse Scholarship Fund

Sarah Waldkoetter, better known as Sally to her family and friends, graduated from Scottsburg High School in 1955. She continued her schooling, eventually becoming a doctoral candidate in nursing. She worked at a few hospitals and became a professor at Columbia University and the University of Cincinnati.

Sally was an active member of the Trinity Lutheran Church in Vallonia, where she lived. She enjoyed "nursing" a Vallonia landmark back to health and led the restoration efforts of a local hotel that was built in 1914.

To show her appreciation for the education and guidance of the faculty of SHS, Sally directed in her estate plan that the Carter-Waldkoetter Nurse Scholarship Fund be established. It will provide assistance to graduating seniors who plan to major in nursing. Sally cared very much for her family and friends, and established this scholarship in memory of Ida Bell Everitt Carter, James Levi Carter, and their descendants who have graduated from Scottsburg High School School, as well as her parents, Harry John and Grace Mildred Carter Waldkoetter.


Sadly, Sally passed away in 2018. She donated her house to the Scott County Community Foundation, which we were able to sell in 2019 to provide the funding for the scholarship. The scholarship will be available for SHS seniors starting in 2022.

Sally was remembered by friends and family as a determined, dedicated, kind person who delighted in helping and giving. Her legacy will continue to live on through this scholarship fund.

SCOTT COUNTY YGC

Mission: Improving the lives of children of Scott County by providing them a voice through philanthropy

Ninety-six youth in grades 5-12 learned about giving their time, talent, and treasure back to the community last year. Some of their accomplishments included:

- Awarded \$7,033 to 12 organizations for youth-related projects/programs;
- Visited grant recipients to see firsthand the impact of their grantmaking;
- Participated in 18 community service projects.
 COVID-19 resulted in the cancellation of many events this year, but the YGC adapted by adding the Clean Earth Challenge and COVID-19 Community Love projects to allow them to serve the community on their own instead of our usual large group events;
- Hosted their 5th Annual Austin vs. Scottsburg Thanksgiving Throwback Throwdown alumni game fundraiser in November 2019, raising \$3,700;
- Learned leadership skills through officer and chairperson positions, grant decision-making, community presentations, and interviews for new and current members.



EARLY CHILDHOOD EDUCATION

Investing in early childhood education is a cause we care about very much. Statistics show that less than half of children between birth and age five years are read to every day by their parents or other family members. Many children are arriving at kindergarten without the skills necessary for lifetime learning. Children who are read to regularly display greater language comprehension, larger vocabularies, and higher cognitive skills.

Eight years ago we partnered with United Way of Scott County to bring the Dolly Parton Imagination Library program to our county. Over 69,000 free age-appropriate books have been mailed directly to children's homes each month, helping to meet our goal of increasing literacy. By the end of 2020, there were 941 children registered for the program, plus over 1,360 kids who "graduated" from the program when they turned five. Through donations from individuals, businesses and civic organizations, as well as grants, community support has helped to ensure this program can continue.

Our Early Childhood Committee was able to host one roundtable for early childhood providers before the COVID-19 pandemic. We also partner with neighboring counties to address kindergarten readiness through the Align Southern Indiana KR A-Team.


COMMUNITY LEADERSHIP



Lilly Endowment GIFT VII Grants

In late 2018, Lilly Endowment Inc. (LEI) announced their seventh phase of the Giving Indiana Funds for Tomorrow (GIFT) initiative. There were several components within this initiative, including a matching grant incentive to build endowment funds. We are pleased to share that in August 2020, we met our goal early through the generosity of over 225 donors. Nine new funds were established during this matching grant period, and the funds will significantly increase our grants and scholarships to the community.

In 2019, we received a \$50,000 community leadership planning grant. This was primarily used to conduct a Community Needs Assessment, which was finished in early fall of 2020. The full report and issue briefs can be downloaded from our website, or a copy can be picked up in our office.



We then received a community leadership implementation grant from LEI for \$75,000 to carry out strategies and activities identified during the planning grant. We are using the findings from the Community Needs Assessment to create a community development plan in 2021. As part of the implementation grant, we provided financial support for early childhood education at Scott County School Districts 1 and 2. We also identified a need for leadership development. We partnered with Leadership Southern Indiana to expand Scott County to its service area. They offer several leadership programs that Scott County residents can participate in, and "Scott County Day" has been added to their DISCOVER community-based program.
