### Message from the Chairman



#### DEAR FRIENDS OF THE FOUNDATION,

On behalf of the Scott County Community Foundation Board of Directors, thank you for your support of the Foundation last year. Because of your generosity, we are on track to take full advantage of the current Giving Indiana Funds for Tomorrow (GIFT VII) matching funds initiative through Lilly Endowment Inc.! Any unrestricted funds raised through December 31, 2020 will be matched \$2 for \$1 by LEI. Building our unrestricted endowments will allow the Foundation to continue awarding grants to worthwhile non-profit organizations serving Scott County.

In addition to the matching fund opportunity, GIFT VII rolled out a new and unique initiative called Community Leadership Grants. These grants are designed to help the Foundation collaborate with local leaders to address high priority challenges and opportunities in Scott County. Since one of the purposes of the grant is to collaborate with local leaders, a committee of elected officials and leaders was formed to assist in applying for the different phases of this grant opportunity. The first phase was for a planning grant and we are incredibly

proud that with the help of the committee, the Foundation's grant application was fully funded for \$50,000. A large portion of the grant funds will be used to complete a Community Needs Assessment. The results and recommendations from that assessment will be critical for the next phase of Community Leadership Grants, which is an implementation grant. Our plans are to create a Scott County Vision Plan that identifies the direction of the community's future.

We are thrilled that GIFT VII enables us to unite and partner with community leaders and officials to help Scott County develop a plan for overcoming challenges while exploring opportunities for growth and positive change. Exciting things are on the horizon for 2020—stay tuned!

As always, thank you for helping the Foundation fulfill its mission of growing and preserving charitable gifts to strengthen Scott County by looking forward and giving back.

#### **SCHOLARSHIP**

These funds assist students with educational expenses. You may customize your preferences for a certain field of study or other criteria, and you can choose to be involved in the selection committee.

#### UNRESTRICTED



## New Funds

#### CASA OF SCOTT COUNTY



Court Appointed Special Advocates (CASA) is a nonprofit that recruits, screens, and trains volunteer child advocates to work in the court system in collaboration with other key agencies, legal counsel, and community resources to represent the best interest of children in juvenile court proceedings. Scott County Judge Roger Duvall was instrumental in getting the program started locally in 2007.

CASA has made great strides to increase the served number of abused and/or neglected children who were waiting for a CASA to be their voice in court. With the help of federal, state, and local grants, as well as donations, they have increased the number of staff and decreased the wait list.

"Unfortunately, grants fluctuate and we cannot always depend on the same amounts coming from them each year," said Executive Director Kelly Shelhamer. "This is the main reason we started our endowment fund. We chose the Community Foundation because of their years of support they have provided to the program."

It only takes one person to change a child's life forever. By donating to the CASA of Scott County Endowment Fund, you are helping them to continue serving the children of Scott County.

#### JOYCE LOWRY BROADY MEMORIAL FUND



Joyce Broady was the fifth of 11 children and it was fitting that she was a middle child because she was nearly always in the middle of all the excitement that went on in such a large family. Many stories have been told about her spunk, her fighting spirit, and her deep love of family in spite of sibling spouts. On their family farm, Joyce learned responsibility, sacrificial love, and loyalty to family.

Joyce and her husband Steve had two children, Stacey Turner and Craig Broady; and are grandparents of Logan and Landon Campbell, and Alli McCarty.

Early in Joyce's life as a parent, she was diagnosed with breast cancer. In spite of many years dealing with cancer, treatment, remission, recurrence, experimental treatments, positive results and never-ending uncertainty, her steadfast faith, unfettered joy and the long-held desire to miss nothing sustained her through longer trials than most will ever know.

Because her desire and ability to help cancer patients was so broad, her family decided to establish an endowment in her memory.

Oftentimes there are expenses not covered by insurance that put an additional burden on families, and this fund will help to alleviate some of those struggles.

When they heard about the Lilly Endowment matching grant opportunity for unrestricted funds, it made sense to establish a permanent fund to benefit the community, thus, The Garten Foundation was born. Now, each year grants will be awarded to carry on their family's spirit of giving back.

"Growing up in a broken home, I truly understand the value of non-profits in our community and investing in our children and our people is the most valuable investment we can make; this fund allows us the opportunity to do just that," stated Chris. "Beth and I believe in Scott County to our core and we couldn't be more excited about helping in this capacity."



Lilly Endowment Community Scholarship recipients receive 4-year scholarships for tuition plus \$900 for books and required expenses. Madelyn Shelton, a graduate of Scottsburg High School, is attending Hanover College. The value of her scholarship is \$150,680. Lilly Endowment has awarded 38 scholarships through the Scott County Community Foundation since 1998.

"Being a Lilly Scholar is an honor and a blessing that has changed the trajectory of my life. Ambitions that were once unthinkable are now in reach because of the doors that the Lilly Endowment has opened. My experiences at Hanover College this semester have allowed me to grow exponentially as a student and as an individual. I am pursuing a double major in history and secondary education. This semester I was selected for the Board of Editors for the Hanover Historical Review. The HHR is an academic journal published by Hanover College comprised of student pieces on a variety of historical topics. I have personal relationships with my professors and I am invested in gaining everything I can from them. It was their support and excellent instruction that helped me earn a place on the Dean's list this semester. ### Scott County YGC

Mission: Improving the lives of children of Scott County by providing them a voice through philanthropy

Eighty-four youth in grades 5-12 learned about giving their time, talent and treasure back to the community last year. Some of their accomplishments included:

- Awarded \$7,339 to nine organizations for youth-related projects/programs
- Visited grant recipients to see firsthand the impact of their grantmaking
- Presented the 6th Annual Helping Hand Award to Marley Fleenor for her work with Marley's Mendings
- Participated in 23 community service

- Learned leadership skills through officer and chairperson positions, grant decision-making, and interviews for new and current members
- Enjoyed team-building through paintball and an afternoon on the lake at Country Lake Christian Retreat

# Early Childhood Education

Investing in early childhood education is a cause we care very much about. Seven years ago we partnered with United Way of Scott County to bring the Dolly Parton Imagination Library program to our

county. Over 58,000 free ageappropriate books have been mailed directly to children's homes each month, helping to meet our goal of increasing literacy. By the end of 2019, there were 876 children registered for the program, plus over 1,100 kids who "graduated" from the program when they turned five. Through donations from individuals, business and civic organizations, as well as grants, community support has helped to ensure this program can continue.

Our Early Childhood Committee also hosted roundtables for early childhood providers and family literacy/resource fair events. We partner with neighboring counties to address kindergarten readiness.

## Community Leadership



#### Lilly Endowment Community Leadership Planning Grant

Last summer, we were notified by Lilly Endowment, Inc. that we were the recipient of a \$50,000 planning grant, with the goal of exploring how we can effectively play a leadership role in our community.

We have contracted with the Applied Research and Education Center at Indiana University Southeast to conduct a community needs assessment. To the best of our knowledge, an assessment of this magnitude has not been done in 20 years.

Our goal is to identify and prioritize Scott County's needs and assets in several areas, including economic development, the aging population, education, income and poverty, substance abuse, health, mental health, infrastructure, recreation, and housing. The resulting study will provide a roadmap for community development in our county.

#### **Education Matters Southern Indiana**

Educational attainment in our region is well below national averages and is having an impact on our community, people, and businesses. In Southeast Indiana, only 25% of our workforce has an associate's, bachelor's or professional degree, compared to 38% nationally.

To address this issue, eight years ago we partnered with the community foundations in Clark, Floyd, Harrison, and Washington counties to create an initiative. Education Matters Southern Indiana. Our goal is to help adults who started, but never completed, some form of post-secondary education. Over the years we have partnered with multiple schools and organizations to reduce the barriers that adults face when trying to achieve their educational goals. Through the generosity of our donors, we provide scholarships as well as employ an adviser to assist students in this region.

#### Align Southern Indiana

Five years ago we joined a 5-county collaborative (Clark, Floyd, Harrison, Scott and Washington counties) to unify our region and transform our communities. Based on a national model, Alian Southern Indiana was created and is now its own 501(c)(3)entity. Through community input from all sectors, five Foundational Areas of Focus were identified: Economic and Talent Development, Education, Regional Leadership, Quality of Life, and Quality of Place. Teams have been formed for each area, with long-term outcomes (for example, the Education team is focusing on kindergarten readiness). We've already seen many successes with the collaborative work being done in these five counties through strategies in each area. Because of this coordination, we are able to impact more people, avoid duplication and address gaps in services, resources, and funding.




