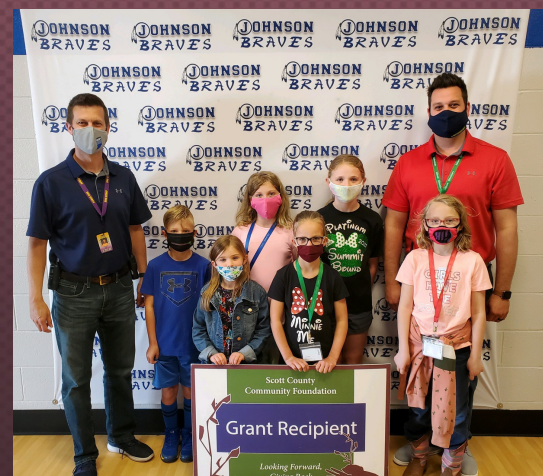

As we reflect on the past year, we have many blessings for which we are thankful. Although COVID-19 continued to impact the community and world, we didn't skip a beat when it came to carrying on programs and initiatives to benefit Scott County. When times are hard, that is when it's most important to be able to respond to the community's needs.

After breaking ground in December 2020 for the new Farmers' Market, we hosted a ribbon cutting ceremony in May 2021 for the beautiful new permanent structure. We worked all year long gathering feedback from the community for the Scott County Vision Plan, a community development guide that will continue the work started from our Community Needs Assessment. We convened local partners to apply for Indiana's READI grant opportunity, and were named one of the finalists in our region's proposal to the state. Our Youth Grantmaking Council continues to develop young leaders into philanthropists. We are excited to share that 2021 was a record year for both grantmaking and assets! And at the end of our fiscal year, we had our 100th endowment fund with the creation of the SHS Classroom Innovation Fund!

All of these activities and more are only made possible because of your support. Thank you for being a part of something that will impact our residents for generations to come.

Types of Funds

We can help you choose a fund that will achieve your charitable goals.

Agency/Designated

These funds are for a school, government agency, church, or nonprofit. This allows the organization to receive annual grants as a dependable source of funding.

Field of Interest

These funds allow you to support a certain field, such as the arts, education, health care, etc. Or, you can support a specific geographic area. The Foundation's Grants Committee will handle the grant process for the area you have identified.

Pass-Through

This fund type is like a charitable checking account. Funds are not invested in the market.

Unrestricted

If you wish to provide resources to the community to meet current and future needs, this is the fund for you. You place no restrictions on this type of fund, entrusting the Foundation's Grants Committee and Board of Directors to choose quality and meaningful grants.

Scholarship

These funds assist students with educational expenses. You may customize your preference for a certain field of study or other criteria, and you can choose to be involved in the selection committee.

Donor Advised

These funds allow a donor to be involved in the giving. Perhaps you want to get your family involved and continue a legacy of giving. Each year you can recommend which charitable organizations or purposes to support.

Endowment funds require a minimum of \$5,000 to establish (scholarships require \$20,000). Ask us about our Acorn Fund program to help reach your goal of creating a fund at a lesser amount.

SHS Classroom Innovation Fund

Long-time Scottsburg educators Brady and Julie Wells created a fund to provide support to SHS after having served as educators for 25 years in Scottsburg. Upon retirement, they moved to Madison and started their second careers. Brady serves as men's and women's cross country coach at Hanover College, while Julie is the

scholarship manager at the Community Foundation of Madison and Jefferson County. Their children, Lauren and Logan, both graduated from SHS, and their granddaughter attends Scottsburg Elementary School. It is meaningful to the family to maintain their commitment to students.

Because of their appreciation for the work done at the school, and to recognize the many outstanding teachers, they established this fund to encourage creative classroom activities. Teachers can request up to \$250 to fund unique projects or classroom needs.



Arthur Gene Mayer Memorial Scholarship Fund

Hardworking. Proud. Intelligent. Driven. Brave. Loving. All these are words that describe Arthur "Gene" Mayer, a family man who left a lasting mark on all who knew him, and even those who didn't.

Gene and his brother Charlie founded Total Concepts of Design. Gene was very proud of the business and for providing employment for so many families in Scottsburg. He was a man of many interests, including reading, cars, boats, motorcycles, hunting, model planes, and more. But out of everything, his favorite thing in the world was his wife, Donna. Gene was extremely devoted to his family and friends. When he died on September 22, 2020, from complications due to COVID-19, he left a giant void in his family and this community. His family decided to honor his legacy by establishing a scholarship in his memory. Graduating high school seniors can apply, and are asked to submit an essay on their work ethic. Gene valued education and promoted the importance of it to his children and grandchildren. He loved seeing others succeed as well as respected those willing to work hard to get what they wanted in life.

Our endowment funds made it possible for \$344,910 to be awarded to the community. This does not include scholarships, which you can read about on the following page.

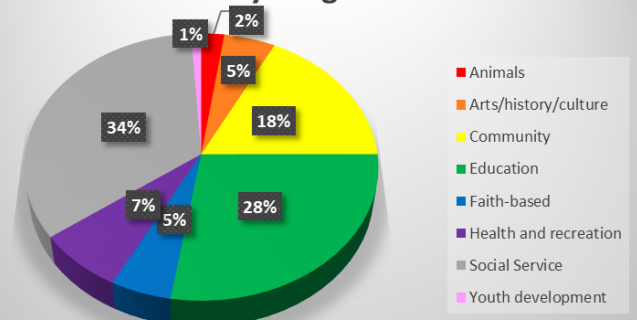

2021 Lilly Scholar Logan Weilbaker

Lilly Endowment Community Scholarship recipients receive 4-year scholarships for tuition plus \$900 for books and required expenses each year. Logan Weilbaker, a graduate of Scottsburg High School, is attending Wabash College. The value of his scholarship is \$199,520. Lilly Endowment has awarded 40 scholarships to Scott County students through the Scott County Community Foundation since 1998.

Most importantly, I am starting to figure out who I am and who I want to be in the world, and I owe the opportunity to do so in large part to the Lilly Scholarship and the Scott County Community Foundation. I eagerly await the coming semester and all the adventures it will bring."

Scott County YGC

Ninety-three youth in grades 5-12 learned about giving their time, talent, and treasure back to the community last year. Some of their accomplishments included:

- Awarded \$7,750 to 12 organizations for youth-related projects/programs.
- Visited grant recipients to see firsthand the impact of their grantmaking.
- Participated in 17 community service projects.
- Led "Camp Philanthropy" at Scott County Family YMCA's summer camp. YGC members played Philanthropy BINGO, Go Give card game, drew encouraging chalk messages, wrote messages about making our community better, and more.
- Hosted their annual Thanksgiving Throwback Throwdown fundraiser, but as a COVID Edition with a donation competition. They raised \$3,068!
- Learned leadership skills through officer and chairperson positions, grant decision-making, community presentations, and interviews for new and current members.

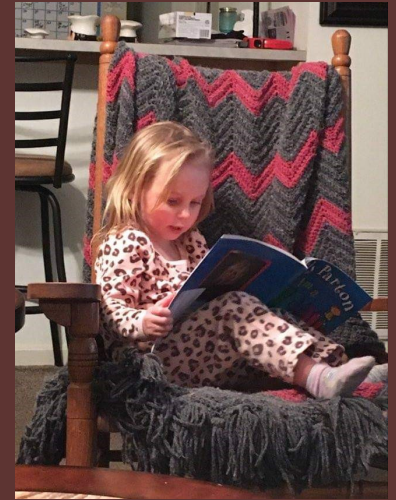
Early Childhood Education

Investing in early care and education has a huge impact on our community and we care about this cause deeply. Several years ago we decided to place a strategic focus on early childhood education. We formed a committee comprised of local educators and early childhood education providers, and began to address issues both locally and through regional collaborations.

Statistics show that less than half of children between birth and age five years are read to every day by their parents or other family members. Many children are arriving at kindergarten without the necessary skills for lifetime learning. Children who are read to regularly display greater language comprehension, larger vocabularies, and higher cognitive skills.

In 2013, we partnered with United Way of Scott County to bring the Dolly Parton Imagination Library program to our county. Over 77,000 free age-appropriate books have been mailed directly to children's homes each month, helping to meet our goal of increasing literacy. By the end of 2021, there were almost 900 children registered for the program, plus over 1,600 children who "graduated" from the program when they turned five. Through donations from individuals, businesses, and civic organizations, as well as grants, community support has helped to ensure this program can continue.

In addition, through a grant from Lilly Endowment Inc., we were able to provide a \$5,000 grant to Scott County School District 2 for their Early Learning Academy, and we will provide \$8,000 in funding to Scott County School District 1 for their Kindercamp program in 2022-2024.

Scott County Bicentennial Gift

In the fall of 2018, Lilly Endowment Inc. offered an opportunity to community foundations to recognize the important role that the community foundation's board of directors plays in both leading the Foundation and serving Scott County. As part of the opportunity, each community foundation that achieved 100% board member giving during a certain time period was eligible to receive an unrestricted grant of \$100,000. We had 13 board members help us achieve this phenomenal return on investment!

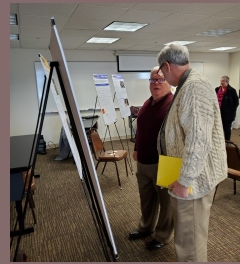
Our Board of Directors chose to use this gift to honor our deep agricultural roots and rich history through a gift of a permanent Farmers' Market structure on the grounds of the Scott County Heritage Center and Museum. While COVID-19 delayed most of Scott County's Bicentennial activities in 2020, we broke ground at a ceremony in December. Construction on the beautiful building was completed by J-A Broady Construction, and a ribbon cutting ceremony was held on May 15, 2021, opening day for the Farmers' Market. Since then, the market has been used by vendors to sell fresh produce, baked goods, farm fresh food, and crafts. Local musicians play each Saturday morning. The space will also be used for educational lunches, demonstrations, and special events. Happy Birthday Scott County!!



Scott County Vision Plan

Using the results of the Community Needs Assessment that was completed in the fall of 2020, we began our next step in our community planning process by creating a roadmap for community development in Scott County. Through a grant from Lilly Endowment Inc., we were able to start work on the Scott County Vision Plan. This plan will address multiple areas of development, including education, housing, quality of place, and other areas crucial to growth and quality of life.

Through an online survey, public workshops, and many meetings, feedback from the community was gathered. The plan will define top priorities that may require county-wide collaboration, and strengthen and create partnerships for successful implementation. It is expected to be completed by the end of winter 2021.



Indiana READI Grant

In May 2021, Gov. Holcomb launched the Regional Economic Acceleration and Development Initiative (READI). Meant to transform communities, the state allocated \$500 million in funding for strategic investments that will make Indiana a magnet for talent and economic growth. They encouraged regional partnerships through these efforts. Thankfully, our region had already formed a collaborative effort in 2017, the Our Southern Indiana Regional Development Authority (RDA). Representatives of Clark, Floyd, Jefferson, Scott, and Washington counties have since met regularly and even developed a plan for a time such as this, Our Region | Our Plan.

After the READI grant announcement, Scott County Community Foundation convened elected officials and other community leaders to discuss how Scott County could leverage this opportunity in a way that would impact future generations. Attendees brainstormed visionary ideas and agreed to submit a grant application to the RDA for the Southern Indiana Youth Sports Complex. This complex would consist of outdoor fields, an indoor multi-purpose facility, and improvements to the YMCA's pool. Future goals would include trails connecting the sites. The RDA Board received 53 applications totaling \$208 million in requests, and Scott County's project was selected as 1 of about 18 projects that were submitted to the state. A large group traveled to Indianapolis for the state presentation (Scott County shown at right), and Our SoIn RDA was awarded the maximum amount, \$50 million! We continue to convene the project partners as we move forward with dreaming and planning our way to a greater Scott County!



Leadership Southern Indiana

In early 2020, we announced a partnership with Leadership Southern Indiana to expand their service area to Scott County. The pilot three-year partnership will allow local community members in Scott County to participate in leadership programs, and help increase regionalism between Scott, Clark, and Floyd counties. Since then, LSI has added a "Scott County Day" to their DISCOVER leadership program, and participants have learned about what our county has to offer. Through a grant from Lilly Endowment Inc., we have provided scholarships to Scott County attendees.

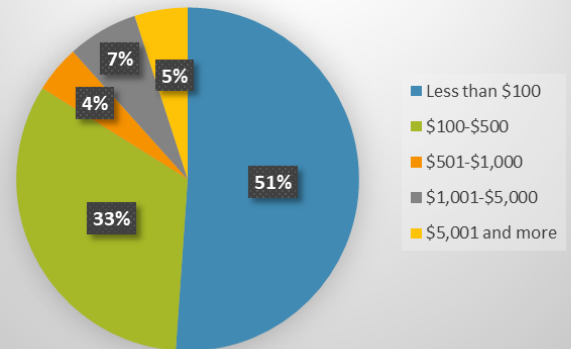

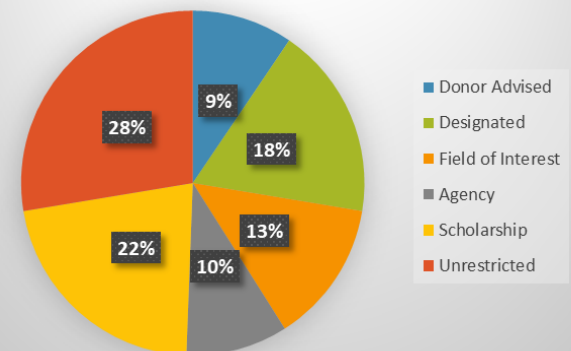

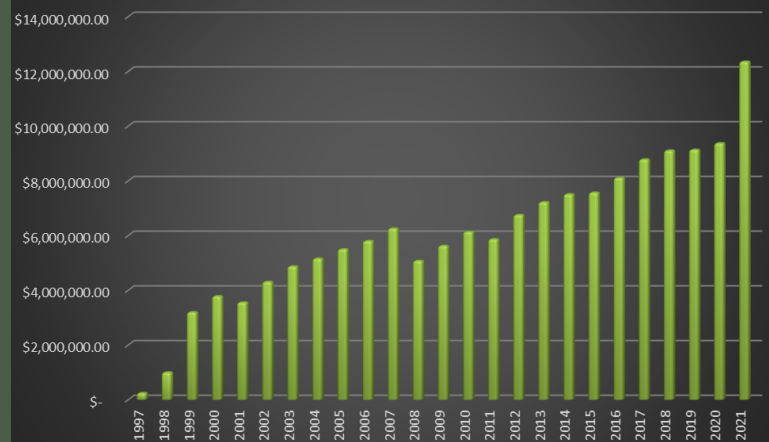
Assets by Fund Type

Looking Forward, Giving Back
