Impact	The proposal impacts a large number of people in Scott County. The demographics of people who will be impacted is clearly defined. Financial	The cost of the project is reasonable, and if applicable, quotes are provided for comparison. There are other dollars already committed to the project. The grant has the potential to improve the applicant's stability and/or capacity.	Basic information is provided, such as budget and plans, but does not give details.
